Greenhouse Gas Emissions of the Proposed Gibbstown/Wyalusing LNG Export Project Analyzed

Report Examines the Project's Climate-Heating Gases Cradle to Grave

Bristol PA – Delaware Riverkeeper Network commissioned a report from energy economists Synapse Energy Economics, Inc. to measure and analyze the full footprint of greenhouse gas emissions that would result from the proposed Gibbstown/Wyalusing Liquefied Natural Gas (LNG) Export Terminal. The <u>report</u>, "<u>Gibbstown LNG Export Terminal</u>: <u>Lifecycle GHG Emissions</u> <u>Analysis</u>" ("the Report") is being publicly released today with a webinar discussing the report's findings tonight at 7pm: <u>Register here.</u>

"Synapse analyzed the lifecycle emissions from the proposed Gibbstown-Wyalusing LNG Project and found that it would emit approximately 211 million metric tons of CO₂e over a 25-year operating period. This is equivalent to 2 million gasoline cars driven every year for the 25 years of operation. The project would have a social cost of carbon of \$53.2 billion (in 2020 dollars) across the project lifetime. Policymakers should consider the entire lifecycle emissions impact of the Gibbstown-Wyalusing Project when deciding whether to allow the project to proceed", **said Jackie Litynski, project manager for the Report.**

Maya van Rossum, the Delaware Riverkeeper said, "It is time for our government officials to stop speaking out of both sides of their mouth – on the one side they recognize the climate crisis as an existential threat, on the other they continue to approve more and more projects spewing climate changing emissions to the atmosphere – and they get away with it because they blatantly ignore the actual emissions they are permitting. It's time for government to stop their willful ignorance, with the Wyalusing-Gibbstown LNG Project being a good place to start by actually recognizing the full climate changing impact of the whole project."

The greenhouse gas emissions of the Gibbstown/Wyalusing project, which proposes to export LNG overseas, must be accurately measured and analyzed to understand its full impact, which is the reason the report was commissioned.
